APPLICATION TO REGISTER/RE-REGISTER AS A CESA EXAMINATION CENTRE

The examinations offered by The Commercial Education Society of Australia may be taken at any college, school, institution or other place approved by the Society as an examination centre.

For new centres a fee of \$100.00 is payable for initial registration and the attached application form should be completed. As part of this registration examination centres must submit a minimum of 50 candidates per year in order to remain registered.

Registered centres may apply to be issued with a certificate attesting to their status as an approved examination centre. Fees are not payable for the issue of such certificates.

Registration is valid for one (1) year, so long as the Society's examination requirements are observed. The Society may cancel registration at any time. The Certificate of Registration issued to the applicant remains the property of the Society and must be surrendered on demand.

Applicants for registration must nominate the person or persons who accept ultimate responsibility at that centre for the fair conduct of the Society's examinations.

Colleges, schools, and other institutions that are approved as CESA examination centres are added to the Society's mailing list, and are sent information regularly about the examination program, changes to the syllabus, and other matters that should assist them in determining their examination needs.

The Society's website is kept up to date. It is possible to read and download from the website a great deal of useful information about CESA activities.
